- 2. Submit all of the information to the Oswego Teachers' E. Federal Credit Union no later than the close of business on Wednesday, April 29, 2020.

The Oswego Teachers' Credit Union scholarship is (7) seven \$500.00 and one (1) \$1,000 award to be paid directly to the member in the form of a check.

2.	The applicant and his/her parent or guardian must sign the Certification and Release Authorization on the back page of this form.

3. The application, transcript and essay must be returned by the deadline. If any portion is incomplete or not included, the application may not be considered.

Selection Process

*Judging will be based on both subjective criteria and weighted, objective criteria.*These include academic performance, the essay, community activities and personal goals.

Application Deadline

Application must be returned to the Credit Union no later than Wednesday, April 29, 2020.
