



Patricia Steele Memorial Scholarship Application

The Patricia Steele Memorial Scholarship was established on October 21, 2020 in memory of Patricia Steele.

The intent of the scholarship is to improve opportunities for CiTi Culinary Arts students to attend a college program which leads to a bachelor's degree in a Culinary field.

In accordance with the guidelines established by Board Resolution, two \$2,000 annual scholarships shall be awarded to worthy and needy CiTi students who meet the criteria of the selection committee. The awarded amount will be paid directly to the recipient's institution of choice.

Eligibility Criteria:

Applicants must have an average of 80% or higher in their CiTi CTE Culinary Arts program and demonstrate a financial need. The applicants must write an essay explaining their 3-5 year goals. The students must be residents of an Oswego County CiTi component school district and accepted in a Culinary Arts, Baking & Pastry Arts, or Hospitality Management program that leads to a four-year bachelors degree. Attendance May be on a full-time or part-time basis.

Instructions to the Applicants:

Finalists for the Patricia Steele Memorial Scholarship shall be selected based on the successful completion of the application.

Applicants must submit the following by **Monday April 5, 2021**:

A completed Scholarship Application

A written Personal Statement

Two Letters of Recommendation

A Letter of Acceptance from the college of the student's choice, indicating a program of study in Culinary Arts, Baking & Pastry Arts, or Hospitality Management.

Finalists may be required to participate in an interview.

It is the applicant's responsibility to insure that the items requested

above are submitted to the CTE Student Services Office or emailed to the

Scholarship Committee by: April 5th, 2021.

Personal Statement: Write a personal statement indicating what the importance of further education and this scholarship means to you. You should include information about your career goals, current educational plans, 3-5 year plan, and financial needs.
