### \*Phase 1 (Raise Awareness) Offerings:

- ❖ Background information of what lead up to the revisions of the NGLS, an overview of the *Preface and Introductory Documents*. ELA & Math  
**Asynchronous- 3 videos (25 min. each)**
- ❖ Overview of *NGLS Preface and Introduction to ELA Standards* documents highlighting the impact on current standards, instruction, and assessment.  
**Asynchronous- 1 video (45 min.)**
- ❖ Overview of the *Advanced Literacy Practice Briefs* to gain a deeper understanding of concepts embedded in NGLS.  
**Asynchronous or Synchronous- (60-90 min.)**
- ❖ Overview of *Lifelong Practices of Readers and Writers*. These practices are expected to be implemented to strengthen students' literacy skills.  
**Asynchronous or Synchronous- (45 min.)**

- ❖ Overview of the framework of expectations (*Blueprint for Improved Results for Students with Disabilities*) to lay the foundation for improved instruction and results for students with disabilities.  
**Asynchronous or Synchronous- (60 min.)**
- ❖ Overview of the *Introduction to the Next Generation Early Learning Standards* and Developmentally Appropriate Practices for PreK-Grade 2. Includes an instructional cycle resource that has a focus on the nature of children’s learning and development in the early grades.

- ❖ Connecting Oswego County Literacy Initiative (OCLI) evidence-based practices to the foundational skills/standards in the Next Generation ELA Standards.

- ❖ Guide teacher teams through a revision process to align current early childhood curriculum (preK-grade 2) with High-Quality Early Learning Resources recommended by NYSED.
