Question 1:

Pg 2 Section 13 says bid forms should be completed on the Excel Vendor Response Sheet via BidNet Direct. Currently there is no excel sheet to download. While this be uploaded at a later date or is the sheet part of the webpage for the bid submission?

Answer: We had a clerical error in our Bid Terms. Note 13 reads:

13) For Electronic Bid Submissions: Bidders must supply a signed photocopy of the bid forms and a completed vendor response sheet (in excel format) via BidNet Direct.

It should read:

For Electronic Bid Submissions: Bidders must submit a signed photocopy of the bid forms and a completed vendor response sheet via BidNet Direct.
