



Burton Ramer Scholarship

The Burton Ramer Scholarship was established on May 22, 1991 in memory of Dr. Burton Ramer who served as District Superintendent of the Oswego County BOCES for more than twenty years. Dr. Ramer had always strongly advocated on behalf of increased educational opportunities for all students regardless of age.

The intent of the scholarship is to improve the opportunity for CiTi students to attend a college program which leads at least to an associate degree. Matriculation in a 4-year degree program is acceptable if it is in the area of study taken while in CiTi's CTE program.

In accordance with the guidelines established by Board Resolution, one annual scholarship shall be awarded to a worthy and needy CiTi student who meets the criteria of the selection committee. Selection shall be made from the applications, personal interviews and the Selection Committee's evaluation of the candidate's probability of success in the post secondary school of the student's choice.

Eligibility Criteria: This scholarship is available to any currently enrolled senior CiTi CTE student, regardless of age. **The student must be a resident of an Oswego County CiTi component school district who has been accepted at a college in a matriculated program that leads to at least a two-year associate degree. Attendance must be on a full-time basis.**

The scholarship will be \$500 for the year, payable to the recipient and the degree awarding institution. Payment of \$500 shall be made at the beginning of the first semester for expenses billed by the college.

Instructions to the Applicants

Finalists for the Burton Ramer Scholarship shall be selected based on the successful completion of the application procedures.

Applicants must submit the following:

1. A completed [Scholarship Profile](#).
2. A [Letter of Recommendation](#) from the applicant's Career & Technical Education teacher
3. A [Letter of Acceptance](#) from the college of the student's choice, indicating a specific program of study

All applications will be reviewed by the Burton Ramer Scholarship Committee.

Finalists may be required to participate in an interview.
